COURSE OVERVIEW

On successful completion of the Below Ground Waterproofing – Industry Best Practice short course, Master Builders will issue a Statement of Attainment for the following Nationally Recognised units:

- CPCCSH2003A Apply and install sealant and sealant devices
- CPCCPD3030B Apply protective paint coating systems

These units of competency can provide credits towards a nationally recognised qualification in *CPC31411 Certificate III in Construction Waterproofing*, which is offered by Master Builders.

ENTRY REQUIREMENTS

As this training may be subsidised by NSW Government, the following eligibility criteria applies:

- You live or work in NSW
- You are an Australian citizen or Australian permanent resident or a humanitarian visa holder, or a New Zealand citizen
- You are no longer attending school

Master Builders also applies the following entry requirements:

- You have a valid White Card (general construction induction card)
- You have successfully completed either the Internal Waterproofing Industry Best Practice or External Waterproofing – Industry Best Practice short course as offered by Master Builders
- You achieve a minimum of 65% correct answers in the Technical Industry Questions within the application process

REQUIRED PARTICIPANT RESOURCES

COURSE MATERIALS

You will not be required to bring any materials or purchase specific books to complete this course. A pen and notepad for individual note taking is recommended. Master Builders will provide all course materials and resources on the day of training.

CLOTHING REQUIREMENTS

Whilst undertaking this course, you will be required to wear closed footwear and appropriate clothing suitable for a building site environment such as high visibility shirts or vests (no thongs, singlets, etc).

COURSE DELIVERY AND ASSESSMENT

The units of competency within this course cover the following topics:

- Identify hazardous materials and other hazards on work sites
- Prepare surface to receive sealants / apply sealants
- Install sealant devices
- Prepare and repair substrate

This course is delivered and assessed face-to-face in a classroom. Assessments will include the following:

- Written assessments designed to obtain evidence of the knowledge required to perform waterproofing
 activities at a competent level. This will include a knowledge questionnaire where you will complete short
 answer questions.
- **Practical assessments** designed to be conducted one-on-one or in a small group. Where practical assessments are conducted in a small group, the assessor will ensure that all aspects of assessment are clearly assessed for each participant in the group (this may involve tasks being completed more than once to ensure that each participant is competent).

• **Assessment on observable behaviour** including oral questions designed to assess technical criteria relevant to techniques required for the units of competency delivered in the course.

You will be provided with a briefing of what is required to successfully complete these assessments; to ensure that you are completely aware of the assessment requirements as well as the required skills, knowledge and behaviour that the assessor will be looking for whilst conducting assessments. You will be offered multiple opportunities to demonstrate knowledge and skills throughout the course. At the completion of all the assessment tasks, you will be provided feedback on your abilities and responses.

Upon completion of the course, your assessor will provide you with a result before progression to the certification stage, and prescribe one of the following outcomes:

- If you are assessed as 'competent' in all units of competency, you will progress to the certification stage.
- If you are assessed as 'not yet competent' in any units of competency, a Statement of Attainment will not be issued and you will be invited to re-enrol into this course again at any time.

TRAINING QUALITY AND CERTIFICATION

Master Builders is responsible under the National Vocational Education and Training Regulator Act 2011 for the quality and delivery of training and assessment and will be the organisation issuing an AQF certificate or statement of attainment to participants.

FEES

This program may be subsidised by the NSW Government Smart and Skilled initiative. Where subsidies are available and applied to the training and you meet the above mentioned eligibility criteria, there is no student fee payable.
