Emergency Services	Yes	No	NA
Has the local Fire Brigade been contacted to ensure the area is safe to inspect			
Obtain verification that emergency services have approved access to the area			
Have the Police been contacted to ensure there are no access restrictions			

Gas, Electricity and Water	Yes	No	NA
Is the gas supply isolated at point of source and safe (obtain verification)			
Are electrical mains isolated at point of source and safe (obtain verification)			
Is the water supply isolated at point of source and safe (obtain verification)			
Check with Dial-Before-You-Dig (phone 1100) before commencement of work

Has the insurer been contacted to ascertain if work can commence			
Are there any restrictions to the type of work which can be carried out			
Obtain verification that the insurer has approved the commencement of work			

Site Safety	Yes	No	NA
Has a risk assessment been carried out to manage the risks associated with			
the working environment and scope of works			
Has a hygienist action plan been put in place to manage any hazardous			
substances on the site (asbestos, chemicals, phosphates, fertilisers,			
insecticides, pesticides etc.)			
Is an engineer required to assess the structural integrity of affected site			
Has a hazardous material (hazmat) report been developed and understood			
If asbestos has been identified, the safe removal of it legally has to be followed			
in accordance with the current Code of Practice. This includes notifying			
SafeWork NSW on 13 10 50			
Does air monitoring need to be implemented			
If the project value exceeds \$250,000, it is a WHS legal requirement to have a			
safe system of work in place, ie Safety Management System

Perimeter fencing adequately erected around boundary of site

Principal contractors name displayed (builders name)			
Contact person's name clearly visible and legible

Contact phone number (contactable 24/7)			
Business name and licence number displayed, if applicable			
Is the information legible, so emergency services, regulators or neighbours can			
contact you			
Erect signage to state construction site, authorised access only			

Personal Safety	Yes	No	NA
Provide appropriate personal protective equipment (PPE) such as face masks			
(minimum type P2), to workers with instructions on its correct fitting and use			
Workers to have an effective means of communication if working alone, remotely			
or in an isolated place e.g. mobile phone or 2 way radio(s)			
Monitor outdoor air quality levels via Air Quality Alerts NSW			
Access health information on bushfire smoke via NSW Health			
Advise workers that if they have concerns about their health, they should seek			
medical advice from their doctor			

Emergency Evacuation	Yes	No	NA
Be aware of any bushfires near the proposed work area(s) and advise workers accordingly, including to follow instructions and advice from emergency services and evacuate the area if needed			
Identify a location specific evacuation plan is in place for the site			
Display the emergency evacuation plan in a prominent position at eye level and printed in a legible format			
Be aware of how many people are involved in the work, while under your control			

Environmental	Yes	No	NA
Are there any waterways or bodies of water that could be affected by			
contaminated air borne materials like ash or embers

As a worker, you have obligations under WHS legislation. You should raise your concerns about bushfire smoke with your Employer or WHS Representative as soon as possible.
